Proceedings

Discussion and Vote on Recorder's Job Description and Duties

- Mayor Evans introduced the proposal to remove the Recorder from having voting privileges.
- S. Bias brought into the conversation that other cities do not allow the Recorder to Vote.
- C. Bryant added that the Recorder is an elected official and the people voted for her in the capacity of all previous Recorders and should legally vote.
- Mayor Evans stated that it didn't matter that previous Recorders voted and the peoples vote did not matter what matter is the law. S. Foster did not agree and stated the removal of the vote should not happen.

• A motion to approve to remove voting rights on council for the Recorder was made by Council Member Scott Bias, seconded by Council Member Carl Harshbarger. Evans, Bias and Harshbarger voted to remove the voting rights. Bryant and Foster voted to keep the Recorders voting rights. Recorder Smith was not allowed to vote per Mayor S. Evans.

Public Comments

• Several members of the audience spoke in support of Recorder Smith.

Adjournment

• The meeting was adjourned at 4:45 P.M. following a motion by Council Member Chase Bryant, seconded by Council Member Scott Foster, and approved unanimously.
