



From the Mayor

Can you believe it is September? Labor Day is right around the corner. This year is flying by, but then, they all seem to do that. We still have a lot planned for this year and want to get as much as possible accomplished before freezing temps set in.



We received great news from the Infrastructure and Jobs Development Council. The City of Milton has received a grant in the amount of \$970,000 to replace water lines on Newman's Branch from Route 60 to the water tank. For the past several months, we have searched for funding for this urgent project, and Thrasher Engineering was preparing a Project Engineering Report necessary for its implementation. We had hoped to obtain a partial grant to help pay for this costly endeavor. However, Delegate Daniel Linville, who has worked tirelessly for the citizens of Milton and all of District 16, was instrumental in helping us get the entire amount funded through the IJDC and the Water Development Authority. **Thank you, Delegate Linville** for actively working with us to find solutions, instead of just watching from the sidelines.

Fire hydrants in Milton were flushed recently to remove sediment in the lines. During this process, five hydrants were found that needed replaced. We sent a letter to Senators Plymale and Woelfel and Delegates Hornbuckle, Linville and Mandt requesting that each of them grant us \$5,000 toward the replacement of these hydrants. Thus far, we have received affirmations from Senators Linville and Woelfel, and Delegate Linville agreeing to provide us with \$5,000 each to help pay for hydrant replacements. **Thank you Senator Plymale, Senator Woelfel and Delegate Linville.** We have not yet heard from Delegates Hornbuckle or Mandt.

In addition, water, sewer and stormwater issues are discussed at the Utilities Board Meetings held at 5:30 pm on the first Tuesday of every month (unless it's a holiday.) If you want to know what is going on with utilities, attend a Utilities Board meeting. As always, the meetings are open to the public.

School has started in Cabell County, and we hope that students will be able to remain in school this year. Milton Elementary has a new pick-up route this year. Parked/waiting vehicles on the previous route blocked residents' driveways, and prevented emergency vehicle's access to homes on certain streets. Change is hard, and it may be difficult to get accustomed to a new route, but give it some time and you will get used to it.



We had planned a community celebration with music, food and activities for the City's 143rd Anniversary. However, with increasing numbers of positive cases of covid-19 and its delta variant, Council decided not to host a festival which could result in higher infection rates. However, we will still have a fireworks display on **September 18th at 9 pm**. The fireworks will be set off in the field behind 1220 South Main Street. We appreciate Donna Clagg permitting us to use her field again for fireworks! Many people observe the display from their vehicles or in smaller groups, so we feel we can go forward with this aspect of the Anniversary Celebration. We hope you enjoy the fireworks!

Public Works Director, Charles Conard

I hope you all enjoyed your summer! We have a lot going on in the City of Milton, and our hope is to get as much done as possible before the freezing weather and snow are upon us.



All our hydrants were flushed recently to clear sediment from the lines. As we have only received a couple complaints since then, it leads me to believe that the hydrant flushing helped. While flushing the lines, a few hydrants were found to be inoperable. Senators Plymale and Woelfel and Delegate Linville each pledged to provide us with \$5000 to help replace the faulty hydrants.

Thrasher Engineering had prepared a Preliminary Engineering Report to replace water lines out Newman's Branch and to upgrade the existing filtration system at the water plant with a pressurized filtration system which would allow more water to be treated daily. We received great news last month that, with help from Delegate Daniel Linville, we obtained a grant for \$970,000 from the IJDC and Water Development Authority to replace the lines out Newman's Branch. We will begin this project as soon as possible.

The American Rescue Plan extends unprecedented funding opportunities for infrastructure investments. We are hopeful that we can also obtain full or partial grant funding for the filtration system once a program is in place at the State level for us to apply. And those are not the only projects that need funding. There are miles of water lines that need to be replaced, and we plan to take this opportunity to get as much done as possible while this funding is available. We are not sitting idly by waiting for a grant to fall into our lap. We are actively searching for assistance. I invite you to attend the Utility Board meetings each month where these issues and plans are discussed at length.



There seemed to be confusion at the public hearing last month regarding the Sewer Bond Ordinance. The main purpose of this project is to reduce I & I— in-flow and infiltration—when stormwater and groundwater enter the wastewater system instead of draining into the ground or being routed to storm drains. In fact, sewer backups caused by the heavy rain in August was a great example of why this sewer project is so important. When stormwater and groundwater enter the wastewater system, the sewer pipes are overrun, potentially causing sewer back-ups to occur. The more I & I in the sewer system, the more we have to pay for treatment. Reducing I & I makes it less likely that sewers will back up, and reduces the rates we must pay to Salt Rock Sewer to process the wastewater.

This sewer project has been in the works since 2018! Contrary to claims, **sewer rates have not been raised in over 10 years**. The new increase will not go into effect until either construction begins or we begin paying on this sewer project.

Fall Clean-Up is scheduled for the week of October 18-22. See the map and schedule on **page 6** to find the day your area will be picked up, as well as the guidelines for what is accepted. We are glad we can provide this service for our residents twice a year.

Work continues at the Maintenance Garage. Steps have been installed and the bathroom and breakroom are nearly complete. Soon we can move all the supplies and equipment over to one facility instead of having everything spread out all over Milton.

Paving should resume soon. Next on our list of roads to pave include Florida Street, the alley by the Senior Center, and portions of Heck Street and Newman's Branch, in no particular order. As we have been doing for the past two years, if water lines under the roadway must be replaced, we do so before the road is paved.

I have also applied through the Chaney Grant and Congressionally Directed Spending Earmarks through the State. We just received notification that we received \$20,000 for a Brownfields Technical Assistance Grant. I will be meeting with WVDEP to utilize those funds in the best way possible in September as the funds will not be available to use until October. I will continue to look for other grants and opportunities to help our City!

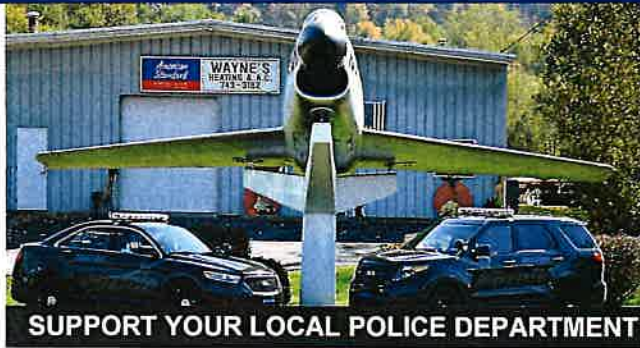

From Chief Joe Parsons

Well, I hope everyone has had a good summer vacation despite the resurgence of Covid in many areas. The next several months will bring a variety of events and happenings to Milton. First and foremost, let's remember that school is back in session which brings school buses and pedestrians out. Please use caution and do not pass a stopped school bus with red lights flashing. This applies to the four-lane section of US Route 60 so that if a bus is stopped in the Westbound lane, then all traffic in both directions in all four lanes must stop. We will be vigilant in enforcement of this law to protect our children.



There is a new traffic pattern for picking up children at the Elementary School this year. A new road has been built and pick-up is at the rear of the school, with traffic going out the back gate onto Orchard Street. This will stop the traffic backup on Church Street which prevented residents of that street from leaving or returning home for the 45 minutes to an hour prior to the gates opening for child pick-up. The Board of Education has sent out information on the new pick-up route. I'd like to thank Tim Hardesty and Shannon Rayburn with the Board of Education for their cooperation in alleviating the Church Street problem.

The West Virginia Pumpkin Festival will be in October and will bring the usual traffic congestion with it. I hope the weather is cooperative and we have a great turnout. I will have all hands-on deck in dealing with the traffic backups; please be patient during these days.

Also, Trick or Treat will be on Saturday October 30th in the City of Milton. I ask everyone to be cautious throughout town as children will be going door to door and also be careful near the April Dawn Park on trick or treat night. I will schedule heavy for this event as well.

The new traffic signs on Mason Street which forbid street parking seem to be working well and traffic is flowing much more freely. We will be monitoring speed on Mason Street and taking action when appropriate.

I was informed that the logging operations out Newman's Branch have concluded, so there should be no more large logging trucks coming out towards US 60.

Fall is approaching, and preparing for the change in weather means preparing our homes as well. One of the first and maybe most important things to check before the cooler weather creeps in is smoke alarms in your house. You should check your batteries once per month to ensure proper functionality of the alarms. Take a minute and go over this smoke alarm safety checklist, it could save a life. Smoke Alarm Safety Checklist

Take this quiz, and find out if you know all you need about the smoke alarms in your home.

Does your home have at least one smoke alarm in each bedroom, near all sleeping areas, and on every level of the home, including the basement?

IF YOU ANSWERED "No" to one or more of these questions, please follow these guidelines for proper installation, testing and maintenance of smoke alarms:

- Smoke alarms should be installed in every bedroom, outside each sleeping area, and on every level of the home
- There are two different types of smoke alarms ionization and photoelectric. An ionization alarm is typically more responsive to a flaming fire, such as a pan fire. A photoelectric alarm is typically more responsive to a smoldering fire, as might occur where a lighted cigarette is dropped on a sofa
- Combination alarms have both ionization and photoelectric detection technologies. For the best protection, use both types of alarms or combination alarms
- Smoke alarms should be interconnected, so that when one alarm sounds, they all do. A licensed electrician can do an interconnection by using hard-wired, multiple-station smoke alarms
- Wireless interconnection of smoke alarms is also available. A licensed electrician may need to replace existing hard-wired smoke alarms with those capable of wireless interconnection
- Replace all smoke alarms, including those that use 10-year batteries and hard-wired alarms, when they are 10 years old or sooner if they don't respond properly when tested
- Smoke alarms should be tested monthly using the test button; everyone in the home should know the sound of the alarm. Save and follow the manufacturer's instructions for testing and maintenance
- Whatever type of smoke alarms you choose, make sure they bear the mark of a recognized testing laboratory

From the Utilities Department

Make sure to submit your requests for pool adjustments by September 3, 2021. These requests will be reviewed at the Utilities Board meeting on Tuesday, September 7th. Remember, only one pool adjustment will be considered for each calendar year.

If you've been to the Utilities Board meetings, you know we are close to beginning construction on a much-needed sewer project. August's heavy rains made it clear how important this project is to reduce inflow and infiltration (I & I) in our sewer system. For more information, please attend the scheduled Utilities Board meetings on the first Tuesday of every month at 5:30 p.m.

City Council and Utilities Board Member Dakota Miller worked with other employees to flush all the hydrants in the City's jurisdiction in an effort to remove built-up sediment in the lines. While doing so, it was discovered that a few of the hydrants were not fully functional. We have asked for, and received, pledges from Senator Woelfel, Senator Plymale and Delegate Linville to help pay to have these hydrants replaced. We can't thank them enough for their generosity. Delegates Mandt and Hornbuckle have not responded to our request for assistance, but we are hopeful that they will recognize the importance of replacing these hydrants not only for fire safety, but for line flushing purposes as well.

Now for the biggest news! Delegate Daniel Linville was instrumental in helping the Utilities obtain a grant of \$970,000 to replace water lines on Newman's Branch. Delegate Linville facilitated a meeting between the City, the Infrastructure and Jobs Development Council (IJDC) and the Water Development Authority to discuss critical needs. Thrasher Engineering had already prepared a Project Engineering Report which was submitted to the IJDC and WDA. Shortly thereafter, those boards voted to provide funds to get this important project underway. Thank you Delegate Linville, the IJDC and the Water Development Authority!



We have identified other areas of need and are in the process of determining how to fund these projects. Infrastructure grants are becoming available, and we hope to qualify for enough grants to complete many projects before the funding dries up.



Finally, I want to remind you to update your telephone number with the Utilities Department so we can contact you in the event of an emergency. Don't just assume we have the correct number. United Daughters of the Confederacy, Cooney Ricketts #2726 Milton

The United Daughters of the Confederacy, Cooney Ricketts Chapter 2726 of Milton, WV decided to treat itself to a fun day of fellowship. It had been over a year since our last group outing, so with great enthusiasm we journeyed on June 15th to the town of Ceredo, WV, where we visited the historical Ramsdell House.

The town of Ceredo was founded by an abolitionist, Massachusetts Congressman Eli Thayer. When the War Between the States broke out, Ceredo was a Union stronghold. The purpose of our visit to the Ramsdell House was to gain insight into its legacy and legend. It has been said to be one of the last stops on the "Underground Railroad" in this part of the state.

The house itself was built on top of one of West Virginia's famous "Adena" mounds, constructed by the indigenous people who are known locally as "The Mound Builders." In recent years, prior to the refurbishment of the Ramsdell House, authorities used ground-penetrating radar to survey the mound. No indigenous remains were found. Legend has it that the Ramsdell family members were buried nearby where an apartment building currently stands but efforts to locate and verify those graves have also come up empty.

We learned many other interesting facts about this historical home. For one, it was built in the year 1858 and was said to be the only brick home in early Ceredo. But, like so many other stories, that too has never been proven. Only a pipe organ and a desk remain of house's original furniture. They have found many of Zophar Ramsdell's letters and personal papers in the attic, as well as many artifacts of daily life and clothing dating back to the 1860s. The house was inhabited by the Ramsdell's family until the 1980's.

Today, the Ramsdell House belongs to the town of Ceredo, and it is listed as a "Home Museum" having been fully furnished in period furniture and freshly restored.
