Recorder Walters called the meeting to order at 7:00 p.m. The invocation was given by Council Member Adkins and the pledge of allegiance was said in unison. Those present were Recorder Dana Walters, Council Members Bob Legg, Tennis Adkins, Carl Harshbarger, Dakota Miller and Troy Nicely. Mayor Tom Canterbury was absent.

Council Member Harshbarger moved to approve the agenda. Second by Council Member Miller. Motion carried.

Recorder Walters read the minutes from the March 1 Regular Meeting, March 8, 14, 21 and 24 Budget Meetings, and March 14 and 24 Special Meetings. Council Member Nicely moved to approve the minutes. Second by Council Member Legg. Motion carried.

Recorder Walters presented the City bills for February 2022 totaling \$152,877.69 for the General Fund. Council Member Miller asked why the total amount of February bills was different on the Profit and Loss Report and the Bill Payment Report. Recorder Walters stated she did not know, but would find out. Council Member Miller moved to approve the bills. Second by Council Member Nicely. Motion carried.

Recorder Walters read the City Financial Report for February 2022. General Fund Total: \$1,159,313.58; Cemetery Total: \$78,786.80; Coal Severance Total: \$3,135.95; American Rescue Plan Act Total: \$560,253.64. Council Member Adkins moved to approve the Financial Reports. Second by Council Member Harshbarger. Motion carried.

Chief Parsons read the Police Report for February 2022. Chief Parsons commended the Police Clerk, Ronnie White, for her work on collecting old fines. Chief Parsons indicated that the Milton Police Department recently had its first pure fentanyl arrest. Council Member Harshbarger moved to approve the report. Second by Council Member Adkins. Motion carried.

Recorder Walters gave the Second Reading of an Ordinance of the City of Milton Amending, Modifying and Reenacting Article 1725.01.1 "Off-Street Parking" of the Codified Ordinances of the City of Milton. Council Member Miller moved to approve the Second Reading. Second by Council Member Nicely. Motion carried.

Recorder Walters read a Proclamation naming April 2022 as Fair Housing Month. Council Member Adkins moved to approve the Proclamation. Second by Council Member Harshbarger. Motion carried.

Jim Peterson advised that the deadline to apply for federally directed spending through Senator Joe Manchin's office is April 10.

Karen Cremeans presented questions about the sewer project.

Linda George inquired about foot and auto traffic in the Gables once the floodwall project is complete.

Council Member Miller stated that Milton would have a community yard sale on June 4, 2022.

Council Member Harshbarger moved to adjourn at 7:.35 pm. Second by Council Member Nicely. Motion carried.
